Through the Ohio Department of Health Early Intervention Program CHSC also provides, at no cost, family training and counseling for children ages birth to three years who are identified with hearing loss.

As part of Jennell's compensation package, she is to be paid a base salary and a maximum of \$12,500 from the 2019 Incentive Plan which 50% is financial results driven and the 50% is mission driven.

50% of the potential payout is contingent on the overall financial results of the Organization. If actual operating results are better than the initial plan, a 50% payout of the maximum will occur. If not, another review will occur and the potential payout will decrease to a range of 0-25% of the maximum.
